Your commitment to public safety allows us to provide the highest level of service to our communities while maintaining fiscal responsibility.

2024 Highlights and Accomplishments

• Public Safety Initiatives

- Successfully completed our first full year of contracted policing for the City of Goodhue.
- Finalized five policing contracts within Goodhue County, ensuring strong partnerships and continued service to our residents.
- o Continued our School Resource Officer (SRO) program with contracts for Zumbrota-Mazeppa and Pine Island schools, furthering our commitment to student safety and community engagement.

Operational Enhancements

- Commissioned our new Mobile Command and Communications Vehicle, enhancing our ability to respond to critical incidents and large-scale events.
- o Implemented our Body-Worn Camera (BWC) Program for both the Patrol Division and the Adult Detention Center, a \$480,000 investment in transparency and accountability.
- Partnered with Dakota County for inmate housing in 2024, with ongoing discussions with Hennepin County for additional options in 2025.
- o Continued work on our facility space and needs assessment for the Law Enforcement Center to ensure efficiency and future operational success.

Professional Recognition & Training

 Successfully passed the MN POST Board training audit, receiving recognition for having "the best records they've seen." Expanded countywide law enforcement training, focusing on liability reduction and advanced investigative techniques.

• Fiscal Responsibility

 Since taking office in 2019, our budget has remained under projections by more than \$3 million, demonstrating our commitment to responsible financial management while maintaining public safety.

Personnel & Staffing

- o Twenty-two new employees have joined our team.
- Eight staff members promoted to leadership roles, ensuring continuity and professional growth within our office.
- o Five dedicated staff members retired, marking the end of their distinguished careers in public service.

• Community Engagement

 Continued to build strong relationships with our communities, emphasizing transparency, outreach, and collaboration.





Investigations

Goodhue County Investigation Division consists of three full time investigators with one rotating investigator (two-year assignment). Two School Resource Officers (SRO) and one Computer Forensic Examiner.

- The investigation division received 284 case referrals for 2024. The primary source of these referrals is from our patrol division on incidents that require further investigative work. These referrals, range from physical and sexual child abuse, physical and Sexual adult Assault, Threats, Fraud, Death Investigations (Suicides, Unwitnessed deaths, Homicides), ICAC (Internet Crimes Against Children) investigations, Theft, Burglaries, Narcotic information, Narcotic investigations, assisting other Law Enforcement agencies, self-initiated investigations and any other crimes or incidents needing further investigating.
- All the investigators will conduct the above related investigations. We have two investigators that handle the
 narcotic related investigations. Both investigators are members of the Southeast Minnesota Violent Crimes
 Enforcement team (VCET). These two investigators will also assist fellow members of the VCET when more
 manpower is needed.
- Two SROs are in Pine Island Schools and Zumbrota Mazeppa Schools.

Our Computer Forensic examiner works collectively with Goodhue County Investigators and other Law
Enforcement agencies when they have cellphones, computers, or any other electronic devices that contain
digital date. The forensic examiner has software, knowledge, and training to extract the digital data(evidence)
from the device to solidify an investigator's case. In 2024 sixty-six devices were examined by our forensic
examiner.

- We have an investigator, and our forensic examiner as members of the MN BCA Internet Crimes Against Children (ICAC) task force. This past year we received an ICAC tip from the BCA of a party in Goodhue County that was sharing CSAM (Child Sexual Abuse Material). We opened an investigation into that individual. During the investigation several search warrants for the house, vehicles, person, and multiple cell phones and computers were executed. During the execution of the search warrants investigators were able to locate the suspects CSAM on the individuals' devises. An arrest of the individual was made for the possession of CSAM
- Members of the Investigation division have done several community engagements talks on a wide range of investigative topics.
- Seventy-three Pre-employment backgrounds were completed.







Key Achievements for Emergency Management:

In 2024, the Emergency Management Division achieved significant milestones in training, preparedness, and disaster response. Staff completed advanced certifications, conducted critical tabletop exercises, and managed FEMA-evaluated drills with no deficiencies. Public engagement was a priority, with outreach during Severe Weather and Winter Safety campaigns, as well as the distribution of school reunification kits. The division also managed a FEMA-declared flooding event and updated the county's Hazard Mitigation Plan. New resources, including an inflatable tent with HVAC and a portable message board, further enhanced operational readiness. These efforts underscore the staff's commitment to safety, resilience, and community collaboration.

• Training and Preparedness:

- Completed full-scale functional exercises for Byllesby Dam and Prairie Island Nuclear Generating Plant, both receiving positive feedback from evaluators.
- Multiple staff members completed high-impact training, including ICS
 300 and Radiological Emergency Response Operations.
- Conducted specialized tabletop exercises for school safety and disaster scenarios.

• Public Engagement:

- Public messaging for awareness campaigns like Severe Weather and Winter Safety.
- Participated in the Goodhue County Fair with MCCV deployment and distributed school reunification kits.

Disaster Response and Planning:

- Managed a FEMA-declared flooding event and successfully completed FEMA-evaluated REP exercises.
- o Updated the Hazard Mitigation Plan and digitized historical records.

• New Resources Acquired:

o Inflatable tent with HVAC, light tower, generator, and portable message board.

Key Achievements for Emergency Communications:

The Goodhue County Emergency Communications Center (ECC), also known as the Public Safety Answering Point (PSAP), had a year marked by collaboration, adaptability, and technological progress. Our dedicated Public Safety Telecommunicators continued to demonstrate resilience and commitment to ensuring the safety and well-being of our communities. The ECC remains committed to providing exceptional service and advancing public safety technologies to serve our community effectively.

• Regional Collaboration:

- Strengthened partnerships within the SEMNECB regional 9-1-1 call handling system, enhancing efficiency, cost savings and redundancies.
- Progressed toward NG911 readiness, focusing on integrated mapping and regional procurement efforts.

Technology Adaptation & Updates:

- Managed a CAD system outage using manual processes while upgrading the hardware and leveraged regional logging for improved call recording.
- Assisted in migration to new Mobile Data Terminals (MDTs) and Body Worn Cameras.
- Replaced the aging Sand Hill <> Red Wing radio microwave system.

- Replaced the aging LEC <> Sand Hill radio microwave system.
- Replaced the DC power plants at the Pine Island and Cannon Falls ARMER sites.
- o Replaced HVAC units at Cannon Falls ARMER site.

• Training & Staffing:

- Welcomed a new Public Safety Telecommunicator and advanced the training program for consistent staff development.
- Celebrated the retirement of long-serving veteran, Wayne Betcher, and ensured smooth leadership transitions.





Adult Detention Center



The ADC is currently fully staffed as on Jan 6th, 2025. The last time the ADC was fully staffed was 2019. We hired nine people in 2024.


The ADC gave up one Detention Deputy position to add a Training and Compliance Sergeant position. The ADC had an internal promotion process and picked the top candidate. The goal was to achieve better compliance with state statues and more efficient training for new and veteran staff.

Two new boarding contracts were added in 2024 with Dakota County and Hennepin County. We are currently holding ten boarders for Hennepin County.

The ADC updated the facility security system. Additional camera monitors were added to Master Control as well as computer tech that runs the facility. The Sheriff's Office was awarded a \$30,000 Grant and County paid \$32,000.



In August ADC added K9 Clark, his handler is Deputy Chad Juliar.
