Summary

It is requested that the County Board award the 2025 Traffic Marking contract to the lowest responsible bidder.

Background

Bids for the Traffic Marking project were opened on February 11, 2025. The 2025 Traffic Marking contract called for striping approximately 240 road miles of the county road system. Providing fresh striping paint annually maintains safe roads for the traveling public.

The next step in the process is to award the contract.

Alternatives

- Award the contract to the lowest responsible bidder.
- Reject all bids.

Recommendations

It is the recommendation of staff to award the 2025 Traffic Marking Contract to Sir-Lines-A-Lot, LLC of Edina, MN with the lowest responsible bid of \$409,531.85; additionally, staff is requesting change order authority in an amount not to exceed available funding.
