Summary

It is requested that the County Board award the CSAH 8 bridge replacement construction contract to the lowest responsible bidder.

Background

Bridge 25516 is located on CSAH 8 in Belle Creek Township. In 2022, the project was awarded \$708,000.00 in federal funds. In 2025, state funds were approved for potential use on the project as well. Bids for the bridge replacement contract were opened on Tuesday, March 11, 2025. The contract consists of the construction of one bridge:

Replace Bridge 25516 on CSAH 8 with Bridge 25624

Two bids were received and are outlined below.

Alternatives

- Award the work to the lowest responsible bidder.
- Award to another bidder.
- Reject all bids.

Recommendations

It is the recommendation of staff to award the CSAH 8 Bridge Replacement Contract to ICON Constructors, LLC of Mabel, MN with the lowest responsible bid of \$1,265,993.46; additionally, staff is requesting change order authority in an amount not to exceed available funding.
