Award Wanamingo Landfill Closure Contract

Date: 30 July 2025

Summary

It is requested that the County Board award the Wanamingo Landfill Closure contract to the lowest responsible bidder.

Background

Bids for the contract were opened on July 28, 2025. Seven bids were received. The lowest bid was from Fitzgerald Excavating & Trucking at \$243,960.00, which is 33.38% under the engineer's estimate. This contract was bid as a lump sum. While County staff could estimate the contract cost based on known quantities, the lump sum nature of the contract required staff to account for potential risks. The level of risk varied between contractors who bid the project, as shown in the Abstract of Bids. While the apparent low bid is substantially under the engineer's estimate, the engineer's estimate is roughly the median value of the bids received.

Alternatives

- Award the work to the lowest responsible bidder.
- Award to another bidder.
- Reject all bids.

Recommendations

It is the recommendation of staff to award the construction contract for the Wanamingo Landfill Closure to Fitzgerald Excavating & Trucking from Goodhue, MN with the lowest responsible bid of \$243,960.00; additionally, staff is requesting change order authority in an amount not to exceed available funding.
