

Award 2024 Bituminous Paving Contract - S.A.P. 025-608-012, et al.

Date: 29 February 2024

Summary

It is requested that the County Board award the 2024 Bituminous Paving Contract to the lowest responsible bidder.

Background

Bids for the paving projects were opened on February 27, 2024. The contract consists of paving approximately 6.4 miles of county road, 4 miles of county trails, the parking lot of the Vasa Salt Shed, and the parking lot at Frontenac State Park (Alt #1). Bituminous paving operations will be performed on CSAH 8, 28, 63, and the trail along CSAH 21.

After bids were opened, the Minnesota Department of Natural Resources opted not to participate and thus Alt #1 will not be included with this contract. The award of this contract shall be based upon the Base Bid.

Alternatives

- Award the work to the lowest responsible bidder.
- Reject all bids.

Recommendations

It is the recommendation of staff to award the 2024 Bituminous Paving Contract to Rochester Sand & Gravel based on their bid of \$3,970,253.21; additionally, staff is requesting change order authority in an amount not to exceed available funding.
