#### Summary

It is requested that the County Board award the 2026 Bridge Maintenance contract to the lowest responsible bidder.

#### Background

Bids for the bridge maintenance contract were opened on Tuesday, March 3, 2026. The contract consists of some or all of the following at each bridge: cleaning and painting bridge piles, providing a special surface treatment on the railing and superstructure, and flood sealing bridge decks:

Bridge 25559 on CSAH 1  
Bridge 25535 on CSAH 2  
Bridge 25575 on CSAH 3  
Bridge 25582 on CSAH 21  
Bridge 25602 on CSAH 62

Four bids were received and are outlined below.

#### Alternatives

- Award the work to the lowest responsible bidder.
- Reject all bids.

#### Recommendations

It is the recommendation of staff to award the 2026 Bridge Maintenance Contract to ICON Constructors, LLC of Mabel, MN with the lowest responsible bid of \$220,107.00; additionally, staff is requesting change order authority in an amount not to exceed available funding.
