Summary

It is requested that the County Board award the 2026 Traffic Marking contract to the lowest responsible bidder.

Background

Bids for the traffic marking contract were opened on March 24, 2026. The contract consists of striping approximately 190 road miles of the county road system. Two bids were received.

Alternatives

- Award the work to the lowest responsible bidder.
- Award to another bidder.
- Reject all bids.

Recommendations

It is the recommendation of staff to award the 2026 Traffic Marking contract to Sir Lines-A-Lot, LLC of Edina, MN with the lowest responsible bid of \$384,925.30; additionally, staff is requesting change order authority in an amount not to exceed available funding.
