

### Summary

It is requested that the County Board approve the attached resolution to accept and approve final payments for the 2025 Bridge Maintenance contract.

## **Background**

This contract provided for the cleaning and painting bridge piles, providing a special surface treatment on the railing and superstructure, and flood sealing bridge decks on the following bridges:

Bridge 25562 on CSAH 1 Bridge 25532 on CSAH 6 Bridge 25554 on CSAH 24 Bridge 25520 on CSAH 30

The contractor for this project was Fitzgerald Excavating & Trucking, from Goodhue, MN. The original contract amount was \$234,113.00, and the final contract amount is \$234,113.00. Final payment to the contractor is \$11,705.65 for the 2025 Bridge Maintenance Contract. Completed contract is 100.0% of the original contract amount.
