Summary

It is requested that the County Board approve the attached resolution to accept and approve final payments for the 2024 Bituminous Paving Contract.

Background

This contract provided for paving on CSAH 8, 28, 63, a trail on CSAH 21, and the parking lot at the County salt shed in Vasa. The contractor for this project was Rochester Sand and Gravel, from Rochester, MN. The original contract amount was \$3,970,253.21, the revised contract amount is \$4,019,900.96, and the final contract amount is \$4,134,048.03. Final payment to the contractor is \$41,856.44 for the 2024 Bituminous Paving Contract. Completed contract is 102.8% of the revised contract amount. The increased contract amount is due to additional shoulder base aggregate placed and additional bituminous that was paved as a result of field conditions.
