Summary

It is requested that the County Board approve the attached resolution to accept and approve final payment of the 2024 Spring Box Culverts Contract.

Background

This contract provided for the replacement of box culverts on township roads in Goodhue County. The contractor for this project was Schumacher Excavating, Inc. from Zumbrota, MN. The original contract amount was \$439,350.47, and the final contract amount is \$433,323.53. Final payment to the contractor is \$23,007.61 for the contract. The completed contract is 98.6% of the original contract amount.
