

LRIP Applications

Date: October 30, 2025

Summary

It is requested that the County Board approve submittal of funding applications for the Local Road Improvement Program (LRIP) for the CSAH 1/CSAH 66 Roundabout project in the City of Red Wing and the CSAH 11/CSAH 62 Roundabout in the City of Pine Island. It is also requested that the County Board approve the attached resolution stating that the County is committed to funding all costs not covered by LRIP for the two roundabout projects, if funding is awarded.

Background

Goodhue County is proposing to apply for LRIP funding for a roundabout project at the intersection of CSAH 1 and CSAH 66 in the City of Red Wing, and a roundabout project at the intersection of CSAH 11 and CSAH 62 in the City of Pine Island. The LRIP has three categories that local agencies can apply for funding: Trunk Highway Corridor Account, Routes of Regional Significance, and the Rural Road Safety Account. Both roundabout projects are eligible under the Routes of Regional Significance category.

Applications must be submitted by December 12, 2025. A signed resolution from the County Board, approving the project and pledging support to fund engineering, right-of-way, inspection, and other non-LRIP eligible costs, as well as LRIP-eligible items in excess of the LRIP grant amount, is required as part of the submittal. Selected projects are eligible for up to \$1,500,000 in funding.

Alternatives

- Authorize County staff to apply for funding through the LRIP and approve the attached resolution.

It is the recommendation of staff that the Board authorize staff to apply for funding through the LRIP and approve the attached resolution, which includes both projects.

NOW, THEREFORE, BE IT RESOLVED, that Goodhue County approves the CSAH 1/CSAH 66 Roundabout Project for the purposes of applying for funding through the LRIP, and if funds are awarded, commits to funding all costs not covered by the LRIP grant amount; and

BE IT FURTHER RESOLVED, that Goodhue County approves the CSAH 11/CSAH 62 Roundabout Project for the purposes of applying for funding through the LRIP, and if funds are awarded, commits to funding all costs not covered by the LRIP grant amount.
