Summary

It is requested that the County Board approve the attached resolution to accept and approve final payments for the CSAH 1 Grading & Paving Contract.

Background

This contract provided for the reconstruction and concrete paving of CSAH 1 from CSAH 9 to 1000 feet east of 100th Avenue. The contractor for this project was Fitzgerald Excavating & Trucking, from Goodhue, MN. The original contract amount was \$5,575,925.79, and the final contract amount is \$5,408,574.36. Final payment to the contractor is \$54,262.71 for the CSAH 1 Grading Contract. Completed contract is 97.0% of the original contract amount.
