

Five-Year Bridge Program

Summary

It is requested that the County Board approve the updated Five-Year Bridge Construction Program.

Background

This update to the Bridge Construction Program is based on the last Five-Year Bridge Program approved by the County Board on 06 Feb 24. Six of the structures on that list were replaced in 2024 and one is in the process of being replaced. Two structures were moved from 2028 to 2027, one was moved from 2027 to 2028, and one moved from 2027 to 2029. These changes amount to observed changes in bridge safety ratings, referred to as LPI or Local Planning Index numbers. There were also 5 new additions to the program with one being placed in 2028 and the remaining four structures added to 2029. As a point of information, the proposed program includes all the County structures (10) that are currently eligible for replacement. Two of these structures are being funded, in part, by federal monies made available through competitive grant opportunities.

• **LT-10** – This is a structure that is currently less than 10 feet and does not meet the definition of a bridge structure. Hydraulic analysis determines that a replacement structure <u>will</u> meet the definition of a bridge structure.

Due to the increased costs of box culverts, higher cement prices, and an increased demand for construction, the funding currently available for bridge replacements is not going as far as it had been. However, with some success securing funding from various sources we look to maintain an aggressive program and will add more structures to the replacement list if additional funding is made available.
