Award Cannon Valley Slope Repair Contract

Date: 2 October 2025

Summary

It is requested that the County Board, on behalf of the Cannon Valley Trail Joint Powers Board (CVTJPB), award the Cannon Valley Trail Slope Repair contract to the lowest responsible bidder.

Background

Bids for the Cannon Valley Trail slope repair project were opened on September 24, 2025. The contract includes repairing slopes at two locations (near Mile 14 and near Mile 16) that have eroded over time. The slope repair at Mile 14 includes the installation of sheet pile and the placement of riprap on the slope adjacent to the trail. The slope repair at Mile 16 includes the placement of riprap on the slope adjacent to the trail. Five bids were received.

Alternatives

- ➤ Award the work to the lowest responsible bidder.
- Award to another bidder.
- Reject all bids.

Recommendations

It is the recommendation of staff to award the Cannon Valley Trail Slope Repair contract to ICON Constructors, LLC of Mabel, MN with the lowest responsible bid of \$1,549,748.50; additionally, staff is requesting change order authority in an amount not to exceed available funding. The CVTJPB is funding 100% of the project costs, using up to \$1,848,674 in state funds, along with a local match. The CVTJPB, at their meeting on September 29, 2025, supported awarding the contract.
