#### **HUMAN RESOURCE DIRECTOR'S REPORT**

County Surveyor Interview Process and Selection. The county interviewing panel unanimously recommended the appointment of Mr. Jeff Ekblad to fill the vacant County Surveyor position. Considering the ongoing review with DDA of the County Surveyor grade and Mr. Ekblad's salary expectations, staff recommended the following options for his placement: • If the grade remains at 117 (post-appeal): Mr. Ekblad would be placed at Step 10. • If the grade increases to 118 (post-appeal): Mr. Ekblad would be placed at Step 9.

**2025 Non-Union Compensation.** The County Board has agreed to a 3% general wage adjustment for 2025 for all positions covered by a collective bargaining agreement. This general wage adjustment takes effect on December 21, 2024. Staff recommended the board approve the same 3% general wage adjustment for all non-union employees effective December 21, 2024.
