Summary

It is requested that the County Board approve the attached Five-Year County Highway Construction program.

Background

This highway construction program is an update to the last approved Five-Year County Highway Construction program, which was approved by the Board on 04 Feb 25.

The 2026 program includes the following:

- Concrete Paving of CSAH 2
- Grading of CSAH 11
- Bituminous reclamation & aggregate surfacing of CR 50
- Bridge Replacement on CSAH 7
- Bridge replacement on CSAH 7

The 2026 construction program consists of grading, paving, and bridge replacements amongst other projects. While there are not many projects on the County system for 2026 the CSAH 2 paving project and the CSAH 11 grading project will constitute a lot of staff time. The CSAH 11 project will begin in the very near future with tree removals and grading work lasting well into the fall. There are also 2025 carryover projects that will be completed early this year.

Presently there are 6 new projects that were able to be added to the 2026-2030 program. The majority of the new projects are bituminous surfacing projects added to 2028 but also includes a roundabout project in 2029 and a County bridge replacement in 2030. Overall, Goodhue County has a total estimated value of projects over the 5-year program of \$74,200,000.

As always, this is a living document; projects may be moved if conditions warrant, new projects arise, funding changes, or other extenuating circumstances require adjustment.

Alternatives

- Revise the program before approval.
- Approve the Five-Year Highway Construction program as presented, allowing staff to present the program to the public and to prepare plans to deliver projects for construction.

Recommendations

It is the recommendation of staff that the Board discuss and approve the attached Five-Year Highway Construction program so staff can work to deliver those projects.

It is also recommended that the County reconsider and develop a new list of projects that are eligible for LOST funding under another agenda item during this Board meeting.
