2024 Official Publication. Minnesota Statute 375.12 requires County Boards to let an annual contract to a qualified newspaper for publication of its official proceedings. This must be approved at the first regular session of the board in January each year. The newspaper will also be designated as the official newspaper for the County's other public notices. Three bids were received. Staff recommends that the County Board open the sealed bids and designate the County's Official Publication for 2024 to the lowest responsible bidder.

Bids received: The Kenyon leader rate was \$3 per inch for each insertion; The News Record rate was \$5.25 per inch for each insertion and Republican Eagle rate was \$4 per inch for each insertion.
