WHEREAS, under Minn. Stat. § 388.18 Subd. 2., at the January meeting prior to the first date on which applicants may file for the office of County Attorney, the Goodhue County Board of Commissioners shall set by resolution the minimum salary to be paid the County Attorney for the term next following.

NOW, THEREFORE, BE IT RESOLVED, that the minimum salary as set by the Goodhue County Board of Commissioners for the elected positions for the County Sheriff and County Attorney shall for the term next following be:

County Attorney - \$127,000  
 Sheriff - \$127,000
