The Goodhue County Board of Commissioners met on Tuesday, June 2, 2026, at 9:00 a.m. in the County Board Room, Red Wing, MN, with C/Flanders, C/Betcher, C/Greseth, and C/Majerus all present. C/Anderson was absent.

**Approve the use of Radio Tower Repairs Fund Balance for Pine Island water tower refurbish capital plan overage.** C/Betcher questioned how we could make sure that we are getting the information we need so that we could do it in the most cost-effective way. In addition, she asked if the Emergency Communications vehicle could help with this situation. Captain Chad Steffen reported typically cities repair towers every 20-25 years. Pine Island moved this project due to monetary concerns. The county always tries to be prepared but there are a lot of other factors involved. In addition, the Emergency Communications vehicle could not act as a tower site.

Captain Steffen noted that he is in communication with Pine Island however, the lead time takes approximately six months. could not be a tower site.

The grant would require a 25% match from the county.
