

Special Meeting - Public Hearing to Discuss Revocation of CSAH 1 from the

intersection of CSAH 1 to 0.36 mi west along old CSAH 1 in Featherstone Township

Summary

It is requested that the County hold a public hearing to discuss revoking the section of old CSAH 1 from 0.36 miles west of CSAH 1 to CSAH 1 to Featherstone Township at this Special County Board Meeting.

Background

In 2006 Goodhue County realigned the current section of CSAH 1 to make the road meet current State Aid Standards. Through this process a portion of the old alignment of CSAH 1 was abandoned, while a 0.36 mile section of the old CSAH 1 roadway was left in place. The right of way for old CSAH 1 was never conveyed to the Township and is still under County ownership. Currently, County maintenance staff are plowing, mowing, and maintaining that section of road. Featherstone Township is maintaining the remaining segment to the west. The current maps show the entire roadway as 299th St.

In order to revoke a county highway, Minnesota Statute 163.11, Subd. 5a requires that the County Board hold a hearing in the town where the highway is located. During this public hearing, the township officers and others are to be given the opportunity to be heard concerning the revocation of this segment of CSAH 1. The above Statute requires that this segment be brought up to current standards before revocation. This segment of CSAH 1 currently meets County standards for a similar road.

County staff has discussed the turnback with the Township. The Township is requesting that a short segment of pavement be removed, the full segment be narrowed to match both a typical Township road and the segment currently owned by the Township to the west, and the placement of riprap to address erosion issues. In addition, the roadway must be maintained for two years by County staff or the County must pay the Township to maintain it. The Township submitted a quote to the County to address the issues with this segment and maintain it for two years. The quote submitted by the Township was for \$25,000. County staff calculated the cost to perform the same work using internal staff, and determined that it would cost approximately \$31,300. This difference is primarily attributed to a difference in purchasing the riprap to repair the erosion issues. Because the quoted cost is lower than the estimated cost to perform the work internally, it is recommended that the County pay the Township to repair and maintain the road.

Once the public meeting is closed, the County Board can consider a resolution revoking the highway and documenting the above decisions.


Alternatives

Recommendations



WHEREAS, Goodhue County realigned CSAH 1 to improve roadway safety; and

WHEREAS, there is a short section of existing CSAH 1 between the new alignment of CSAH 1 and 299th St that cannot be on the County State Aid Highway (CSAH) system and should not be on the County's system since it is now a dead end (see attached exhibit); and

WHEREAS, the County Board may, according to Minnesota Statute 163.11, Subd. 5 revoke any such portion of highway by resolution, in which case said portion of the revoked highway reverts to the town in which the road is located; and

WHEREAS, this portion of CSAH 1 to be revoked are described below:

Commencing at the Southwest corner of said Section 11; thence North 00 degrees 10 minutes 11 seconds West along the west line of said southwest quarter, 530.61 feet to the centerline of 299th Street and the point of beginning; thence North 69 degrees 03 minutes 40 seconds East 477.02 feet; thence 198.37 feet along a tangential curve concave to the southeast having a central angle of 09 degrees 33 minutes 09 seconds and a radius of 1189.78 feet; thence North 78 degrees 31 minutes 01 seconds East, tangential to the last described curve, 360.75 feet; thence 333.28 feet along a tangential curve, concave to the southeast, having a central angle of 22 degrees 52 minutes 39 seconds and a radius of 834.69 feet; thence South 80 degrees 14 minutes 10 seconds East, tangential to the last described curve, 162.94 feet; thence 144.77 feet along a tangential curve concave to the northeast having a central angle of 17 degrees 15 minutes 57 seconds and a radius of 480.40 feet; thence North 82 degrees 29 minutes 53 seconds East, tangential to the last described curve, 100.34 feet to the westerly line of parcel 5, Goodhue County Right of Way Plat No. 183, on file and of record in the Goodhue County Recorder's office, Goodhue County, Minnesota, and there terminating.

The sidelines of which are lengthened or shortened to said west line of the Southwest Quarter and said westerly line of said Parcel 5.

WHEREAS, the County served notice by certified mail to the Featherstone Township Supervisors: David Schwartau, Joe Tousignant, Todd Kuyath, Lee Kloeckner, and Carl Bang; and

NOW THEREFORE BE IT RESOLVED, that the Goodhue County Board of Commissioners does hereby revoke the County's interest in the real estate used as that part of old CSAH 1 as described above, in which case said portion of revoked highway reverts to Featherstone Township.
