**Mn DNR Land Acquisition.** Ryan Tebo, Rochester Area Assistant Area Wildlife Manager, addressed the board and recommended the board approve a proposal for the State of Minnesota to acquire approximately 40 acres of restored riparian grassland, native grassland, and woodland in Minneola Township, Goodhue County, in partnership with Pheasants Forever

Moved by C/Anderson, seconded by C/Majerus, and carried to approve the proposed acquisition of property to become addition to Woodbury State Wildlife Management Area with the condition that the taxes are paid in full.

#### **PUBLIC WORKS DIRECTOR'S REPORT**

July Kenyon Cleanup Day. County Engineer, Jess Greenwood, summarized the cleanup days in Kenyon and asked the board for direction on how to proceed with future cleanup events, given three events remain. A total of 35 customers have brought items to the two events. The County has collected \$1,450.10, which includes sales tax. While actual expenses are not completely known, it is estimated that the County has accrued approximately \$1,575 in costs, consisting of \$600 in dumpster rental and \$975 in disposal costs. This amount does not include costs for staff time/overtime paid or County equipment used.

There was board consensus to have one more cleanup day in Kenyon in September.
