

Contract Policing Minimums

- Many models are used to calculate police staffing.
- Crime based models use weighted calculations that include Part 1
 Crimes (robbery, serious assaults), Part 2 Crimes (assaults, drugs,
 forgeries), traffic accident and all calls for services to determine the
 number of Officers needed to staff a patrol beat.
- Population based models use varying means to calculate how many full time Officers are needed for a jurisdiction. Goodhue County uses a population model to set the minimum contract hours needed.
