SUBJECT: Tax Forfeited Land DNR Request

DATE: May 6, 2025

Background

In 2019, staff received an inquiry from the Minnesota Department of Natural Resources Division of Parks and Trails (DNR). The DNR stated that they had been working with the State Chapter of the Izaak Walton League on acquiring parcels 47.029.1900, 47.030.2100 and 72.120.0370. During the donation/transfer process, it was discovered that the state chapter didn't own the parcels. The Zumbrota Chapter #220 that had gone defunct owned the parcels. At that time, the DNR was informed that the parcels had delinquent taxes and if they remained unpaid, the parcels would go tax forfeited. The three parcels forfeited in May of 2021 and ownership was changed to the State of Minnesota in trust for local taxing districts. On January 11, 2022, staff received notice from the DNR requesting ownership of the parcels as part of their Goodhue Pioneer Trail extension from Zumbrota to Mazeppa. On February 1, 2022, the County Board approved the DNR's request for acquisition. Staff have been working with the DNR to transfer ownership of these parcels. On August 15, 2024, the parcels were reclassified as conservation land. Staff was notified on March 25th that the DNR was no longer interested in parcel 72.120.0370.

Discussion

Enclosed is the DNR executed application for release of Tax forfeited land and a resolution required to release lands from the taxing districts. Once the DNR receives the executed resolution, they will draft a Certificate of Acceptance to be recorded. That action will complete the transfer.

Recommendation

Staff recommends the Goodhue County Board approve the resolution transferring parcels 47.029.1900 and 47.030.2100 to the DNR.

AND

The abandoned one hundred (100) foot wide right of way of Chicago, Milwaukee, St. Paul and Pacific Railroad Company in the Southeast Quarter (SE¼) of Section 30, Township 110 North, Range 15 West, Goodhue County, Minnesota, between the east line of said quarter section and a perpendicular (line) at the present end of said track at Engineering Station 2832+17, a point in the center line of said track at a distance of 445 feet northeasterly, measured along the center line of the present track from its intersection with the west line of the Southwest Quarter (SW¼) of the Southeast Quarter (SE¼) of said Section 30.

II.

That there is need for such lands and the applicant desires to obtain such land for conservation purposes.

WHEREFORE, the applicant petitions the County Board that said lands be released from the trust in favor of the taxing district for the aforesaid purposes as provided by law.
