Notice is hereby given that Online Bids will be received by the Goodhue County Public Works Director until 1:00 p.m. July 28, 2025 via QuestCDN, for the furnishing of all labor and materials for the Phase 2 Final Closure Construction of the Wanamingo Demolition Debris Land Disposal Facility.

The bid opening will be held at the Goodhue County Public Works Office, 2140 Pioneer Road, Red Wing, MN 55066 at 1:00 p.m. on July 28, 2025 at which time the bids will be publicly opened via QuestCDN and read aloud. The bid opening will also be conducted via Microsoft Teams.

Major components of the Work include:

- A. Site grading to contract drawing Intermediate Cover elevations.
- B. Installation of 12" Barrier Layer
- C. Installation of general soils rooting zone layer with 6-inch vegetated topsoil cover.
- D. Cultivation of existing topsoil over the Closed Phase A and Closed Phase 1 areas and re-planting of turf.
- E. Excavation of silty soil sediment and remediation of existing sedimentation basin.
- F. General site grading.
- G. Stormwater and erosion control management
