
### Anticipated Funding from LOST

- Department of Revenue anticipated \$1,700,000 annually
- Other Counties found the Department of Revenues forecasts to be low
- Staff assumed \$2,000,000 annually

# Actual Revenue Received from the Department of Revenue

- 2019 = **\$2,739,520**
- 2020 = **\$ 3,482,460**
- 2021 = **\$ 3,968,968**

# **Eligible Projects**

The enabling legislation requires that the County Board adopt a list of Highway Construction Project that these LOST funds are Eligible to be used for.

Options for Establishing the list of Eligible Highway Constructions include:

- Adopting the current Five Year Construction Program by either:
  - Adopting the current five year program once every five years.
  - Adopting the current five year program every year when an updated program is adopted by the Board.
- Simply listing ALL the segments of County State Aid Highways and County Roads once. This list would need to be revised if there were new segments added to the County State Aid Highways and/or County Roads.
