Absent: Janie Farrar, Barbara Pratt, Roxanne Bartsh, and Barney Nesseth, with Mairi Doerr arriving at 1:30 and Mike Melstad leaving at 1:30.

Mike Melstad called the meeting to order at 12:25 PM. A quorum was not present, therefore the June 14th meeting minutes were not approved.

Vince Cockriel was awarded a certificate for his service on the Park Board and assistance with the master planning projects completed in 2016 and 2017.

Scott Roepke provided a Cannon Valley Trail update. Trail pass sales are down slightly this year, likely due to weather. The CVT chose the company SEH for bridge design on their upcoming improvement projects. They received grant approval by the Greater MN Regional Parks and Trails Commission, and are now working on the requirements for the DNR portion of the application.

Greg Isakson gave an update on the Hastings to Red Wing Trail. Trail progress is currently on hold, waiting for a City of Red Wing staff member to meet with the Jones-Lake group.

The Mississippi Blufflands State Trail is currently working with the City of Red Wing on a trail segment design from Levee Park to Colvill Park.

Greg Isakson and Ken Burns discussed the Stanton Township zoning and permitting at Byllesby Park. The park land is currently zoned R-1 residential by the township. In addition to typical township building permits, this would require the County to apply for permits for any projects that may increase use of Byllesby Park (dog park, camping, movie night, fish cleaning station, pavilion, etc.) Stanton Township is also considering requiring event permits for larger events held at Byllesby Park. They have yet to define the parameters that would require a township permit.

County Staff has begun further breaking down park planning that was done by a sub-committee comprised of Mike Melstad, Barbara Pratt, and Mairi Doerr. Staff has broken down the projects and their design into specific years and funding sources. This plan/budget indicates that the pavilion will be the first item designed, as determined at the last meeting. Park Board members were asked to review this document in preparation for the next meeting.

Mairi Doerr called the meeting to order at 1:35 PM. It was moved by Brad Anderson, seconded by Mike Melstad, and carried to approve the May 8, 2018, Park Board Minutes.

Roxanne Bartsh provided an update on the Goodhue Pioneer Trail. The Goodhue Pioneer State Trail is in a good position to receive money from the LCCMR. The GPST did not receive any bonding money, but there is a possibility to use leftover funds from previous two-year bonding cycle for the Hawkinson property, which would cost approximately \$400,000 for acquisition.

There was also an update on the Mississippi Blufflands State Trail. The City of Red Wing was given money in the name of the trail to tie Levee Park to Colvill Park. The money received will not be enough for the segment.

Greg Isakson provided an update on the Nielsen Memorial Preserve. The GMRPTC rated the preserve as a "medium", which concludes that it is ineligible for grant funding. The GMRPTC included some suggestions to increase the application ranking to "high". Reapplying will be important to the future of the park. Park Board members discussed resubmitting the application for the park as a Special Recreation Feature Park in order to maximize the rating, under the suggestion of the GMRPTC. Before the application process, Park Board members discussed the possibility of having an ecologist from the Department of Natural Resources inventory the special features of Nielsen Memorial Preserve.

Park Board members began discussions on the 110 acre County-owned parcel on Lake Byllesby. See Land Committee Notes. It was moved by Mairi Doerr, seconded by Roxanne Bartsh, and carried to acknowledge that the 110 acres is in present and best use if the county maintains ownership, and to not sell it at the present time. Park Board members did have a desire to have staff look into the current and possible future zoning.

Park Board members discussed prioritizing the Byllesby Park improvements. It was determined that the pavilion is be of highest importance and that the project will be the priority for the 2019 GMRPTC grant application. Having restrooms and running water on the premises is also be of utmost importance. Greg Isakson will have County staff and Sentence-to-Serve crews work on smaller projects for the current summer and next spring. There was also some discussion on applying for funds for building the dog park. A GMRPTC grant application would be due July 31, 2018. It was determined that projects such as the fishing pier and day boat slips would need to have DNR involvement before moving forward.
