C/Majerus welcomed C/Scott Safe who was filling in for Ron Allen, then asked if there were any disclosures of interest. There were none.

The board recessed to hold the 2019 Budget and Tax Public Comment meeting. The board reconvened at 7:15 p.m.

2019 Budget, Levy and Capital Plan. Staff recommended the board approve the 2019 budget, levy and capital plan as presented. The board could either take action on the issue at this meeting or at the December 18, 2018, board meeting.

C/Nesseth shared a list of reductions and proposed the levy be reduced by \$1 million. C/Nesseth made a motion to reduce the levy by \$1 million. C/Majerus seconded the motion. Motion failed.

Moved by C/Nesseth, seconded by C/Majerus, Motion failed (2-3-0) with C/Anderson, C/Safe and C/Drotos dissenting to approve to reduce the proposed 2019 levy to \$34,963,370.

C/Anderson questioned why the board was just receiving this list now. In addition, some of the items had been discussed and found to not be feasible. C/Drotos agreed and was not in favor of last minute reductions without knowing the consequences the county could face if the board chose to make any of the proposed reductions.

C/Anderson made a motion to approve the budget, levy and capital plan as presented.

Moved by C/Anderson, seconded by C/Drotos, and carried (3-2-0) with C/Nesseth and C/Majerus dissenting to approve the following resolution approving the 2019 budget, levy and capital plan:
