RE: 2020 Per Diem Rates

On December 17, 2019, the County Goodhue County Board set 2020 County per diem payment at \$50.00 per day. This will be also utilized for the HHS Board Members meetings as allowable under MS 375.055.

This is to request the HHS Board adopt the rate set by Goodhue County Board.

The 2020 HHS budget was approved at the December 3, 2019 County Board Meeting. The levy request represents an increase in levy of \$394,493 (5.30%) over the 2019 approved levy. The overall 2020 budget increased \$929,576 (5.49%) over the 2019 budget.

Action Requested:	Approve Regional Contract for additional Employment and Training services for Supplemental Nutrition Assistance Program (SNAP) customers.		

BACKGROUND:

The Department of Human Services has continued to offer some additional employment and training funding for SNAP customers. Each county grant amounts are small so it has made sense for counties that wish to seek these funds to come together and contract with the state and regional employment and training service provider – Workforce Development Inc.

This is now our fourth year collaborating for this additional funding. Wabasha County has agreed to continue to act as the fiscal agent.

The Workforce Development Inc. will utilize the available funds of \$4,115 from 10-01-2019 through 09-30-2020 designated for direct program expenses and \$672.00 designated for support services for the four counties.

RECOMMENDATION: HHS department recommends approval of the above.

AGREEMENT FOR PROVISION OF SUPPLEMENTAL NUTRITIONAL ASSISTANCE PROGRAM (SNAP)

The Wabasha County Board of Commissioners through its designated agency, the Wabasha County Department of Human Services, 625 Jefferson Avenue, Wabasha, MN 55981-1589 (651) 565-3351, acting as Fiscal Agent for the counties of Goodhue, Houston, Mower and Wabasha or any successor organization developed with at least one of the participating counties hereinafter referred to as the "Counties" and the Workforce Development, Inc., 1302 Seventh Street NW, Rochester, MN 55901 (507) 292-5166, hereinafter referred to as the "Contractor" enter into this agreement for the period of October 1, 2019 through September 30, 2020.

WITNESSETH

WHEREAS, M.S. 256D.051 requires counties to provide a SNAP Program to eligible persons and allows counties to subcontract for duties under subd.2 of M.S. 256D.051, and

WHEREAS, the Job Training Program, under WIA, administered by the Workforce Development, Inc. is knowledgeable regarding M.S. 256S.051 and of the methods and techniques involved in providing the services in M.S. 256D.051;

NOW, THEREFORE, in consideration of the mutual understandings and agreements set forth, the Counties and Contractor agree as follows;

Available Funds \$4,115 10-01-2019 through 09-30-2020 designated for direct program expenses; \$363 (7.5% admin) and \$672 designated for support services for the four counties.

I. Services to be Provided

- A. SNAP Orientation
- B. Employability assessment and development plan
- C. Job search classes
- D. Referrals to available employment assistance programs/agencies

II. Delivery

The Contractor agrees to the following:

- A. The SNAP Program services will be made available at the Workforce Development, Inc. office locations in each county.
- B. The services available for regular WIA participants may be available for SNAP participants, depending on the funding.
- C. The program will be a minimum of 20 hours per week and a maximum of 32 hours per week for period of eligibility.

- D. Upon referral of a SNAP registrant, the Contractor will provide an orientation to the SNAP Program and notify the Counties of attendance.
- E. An employment plan with all of the required SNAP activities and individual responsibilities will be prepared by the Contractor and submitted to the participant each month. This employment plan will prescribe the necessary activities to be undertaken during the month by the participant in order to continue receiving monthly SNAP benefits. A copy will be sent to the Counties.
- F. The Contractor agrees that in order to protect itself, as well as the Counties, under the indemnity agreement, it will at all times have and keep in force a professional liability insurance policy with limits of \$1,000,000.00.
- G. To facilitate interagency cooperation, the Counties and Contractor shall be considered adjunct agencies for the purpose of meeting the training requirements of the SNAP Program. Participant referral information and related contracts to provide training services and participation information shall be communicated between program related personnel involved with this program. Program participants will be apprised of the service agreement between the Counties and Contractor.

III. County's Responsibilities

- A. Refer all persons eligible for the SNAP program to the Workforce Development, Inc. by completing a WF1 referral. The program moves to a voluntary status on December 1, 2018. Referrals will be made noting the participants opportunity for employment services at no cost to the participant.
- В. The Counties will reimburse the Contractor for invoiced costs at the following rate: \$400.00 per SNAP enrollment for staff services, including orientation. assessment, preparation of an Employment individualized counseling, Job Search instruction, and vocational assessment, referrals to other agencies, job referrals and direct marketing contracts with employers. Actual costs for services will be billed each month up to \$4,115 direct program, \$363 administration and \$672 support funds for this program year. This includes the time spent sending notices to the participants and the Counties, in addition to tracking the participants' compliance.
- C. Complete any state mandated Information System forms or reports for SNAP registrants at time of registration.

D. Inform Contractor prior to referring any participant who is unable to communicate in the English language. The Contractor will then arrange for an interpreter.

IV. Contractor Responsibility

- A. The Contractor agrees that during the existence of this agreement that it will indemnify and hold harmless the Counties from any and all liability which may be claimed against the Contractor (1) by reason of any reimbursable cost resulting from an eligible client suffering injury, death, or property loss while participating in services from the Contractor or while being transported to/from said premises in any vehicle owned, operated, chartered, or otherwise contracted for by the Contractor or (2) by reason of any said client causing injury/damage to another person or property during any time when the Contractor has undertaken or is furnishing the service called for under this agreement.
- B. The Contractor agrees to comply with the Civil Rights Act of 1964 (Titles VI and VII); Rehabilitation Act of 1973 (Section 504); and Minnesota Human Rights Act (Chapter 363).

V. Financial Arrangements and Reporting Procedures

- A. The Contractor agrees to furnish the following reports to the Counties:
 - 1. Verification that the participant kept their initial appointment as scheduled.
 - 2. A copy of the employment plan.
 - 3. Monthly communication with the Counties verifying each participant's program participation.
 - 4. Any Management Information Systems forms or subsequent reports for SNAP required by the Counties.

VI. Other Conditions of the Contract

A. The Contractor shall allow personnel of the Counties, Minnesota Department of Human Services, and the Minnesota Department of Employment and Economic Development, access to the Contractor's

records at reasonable hours in order to exercise their responsibility to monitor the services and audit the financial records.

B. Audit and Records Disclosure:

The Contractor agrees to maintain records at 1302 Seventh Street N.W., Rochester, MN 55901 for a period of six years to allow persons from the Minnesota Department of Human Services and the Minnesota Department of Employment and Economic Development, or their designees, access to records at reasonable times for audit purposes.

- C. The use or disclosure, by a party, of information concerning a client in violation of the Data Privacy Act or for any purpose not directly connected with the administration of the County's or Contractor's responsibility with respect to the Purchased Services hereunder is prohibited except on written consent of such eligible client his/her responsible parent or guardian.
- D. This contract may be cancelled by either party, upon 30 days notice, in writing, delivered by mail, or in person.
- E. Alteration to or waivers of provisions of this contract shall be valid only if they are in writing and duly signed by both parties.
- F. In the event there is a revision of state regulations which might affect this agreement, all parties will review the contract and renegotiate those provisions necessary to bring it into compliance with the new regulations.
- G. Subcontractors are subject to all requirements outlined in this agreement.
- H. The Counties agrees to provide for a Fair Hearing and Grievance Procedure in conformance with Minnesota Statues, Sections 256.045, and in conjunction with the Fair Hearing and Grievance Procedures established by administrative rules of the State Department of Human Services.

VII. <u>Non-Discrimination Statement:</u> The CONTRACTOR will comply with:

- A. Title VI of the Civil Rights Act of 1964, as amended by the Equal Employment Opportunity Act of 1972, which generally prohibits discrimination on the grounds of race, color, or national origin, and applies to any program or activity receiving federal financial aid.
- B. Title VII of the Civil Rights Act of 1964, as amended by the Equal Employment Opportunity Act of 1972, which generally prohibits discrimination because of race, color, religion, sex, or national origin and

- applies to all employers, including State and local governments, public and private employment agencies and labor organizations. Any employment and training program sponsor or contractor, which falls within one of these definitions, would, of course, be covered by Title VII.
- C. The Rehabilitation Act of 1973, as amended, which generally prohibits discrimination on the basis of handicap in all federally funded programs.
- D. The Age Discrimination in Employment Act of 1967, as amended which generally prohibits discrimination on the basis of age against persons 40 years of age and over.
- E. The Equal Pay Act of 1963 amended the Fair Labor Standards Act and which generally provides that an employer may not discriminate on the basis of sex by paying employees of different sexes differently for doing the same work.

- G. The Age Discrimination Act of 1975, as amended, prohibits unreasonable discrimination on the basis of age in programs or activities receiving federal financial assistance.
- H. The Americans with Disabilities Act of 1990 (P.L.101-336), as amended, which prohibits discrimination based on disabilities in the areas of employment, public services, transportation, public accommodations and telecommunications.
- IX <u>Affirmative Action:</u> The Contractor certifies that it has received a Certificate of Compliance from the Commissioner of Human Rights pursuant to Minnesota Statues, Section 363.073.
 - A. The Contractor agrees to comply with the requirements the Uniform Relocation Assistance and Real Property Acquisitions Act of 1970 (Public Law 91-646), which provides for fair and equitable treatment of persons displaced as a result of federal or federally assisted programs.
 - B. The Contractor agrees that program participants shall not be employed in the construction, operation or maintenance of that part of any facility, which is used for religious instructions or worship.

- C. The Contractor agrees to comply with the provisions of Chapter 15, Title 5 of the United States Code with regard to political activity.
- The Contractor further understands and agrees that it shall be bound by the D. Minnesota Government Data Practices Act (Minnesota Statutes 13.03-13.04) with respect to "data on individuals", (as defined in 13.02, subd. 5 of that statute) which it collects, receives, stores, uses, creates or disseminates pursuant to this agreement. The Contractor provides assurances to the Counties that it will comply with Health Information Portability and Accountability Act (HIPPA) requirements necessary to protect individual identifying health information (IIHI). Use and disclosure will require that all IIHI be: appropriately safeguarded; any misuse of IIHI will be reported to the Counties; secure satisfactory assurances from any subcontractor; grant individuals access and ability to amend their IIHI; make available an accounting of disclosures; release applicable records to the Department of Human Services if requested; and upon termination, return or destroy all IIHI in accordance with conventional record destruction practices.
- E. The Contractor agrees to comply with all applicable standards, orders, or requirements issued under section 306 of the Clear Air Act (42 U.S.C. 1857 (h), section 508 of the Clean Water Act (33 U.S.C. 1368), Executive Order 11738, and Environmental Protection Agency regulations (40 CFR Part 15).

It is understood and agreed that the entire agreement of the parties is contained herein and that this agreement supersedes all oral agreements and negotiations between the parties related to the subject matter hereof, as well as any previous agreements presently in effect between the Counties and the Contractor.

BACKGROUND:

Sex Trafficking Awareness Month calls attention to the fact that human trafficking and exploitation is widespread and impacts every person in our communities. Sex trafficking is a form of modern-day slavery and occurs when an adult or child is recruited, harbored, obtained, or exported through force, fraud or coercion for the purposes of sexual exploitation. This crime occurs throughout Minnesota and impacts Minnesota children and families from diverse geographic and social-economic backgrounds.

In March of 2018, Goodhue County received grant funds to develop a multidisciplinary protocol to respond to sexual exploitation and sex trafficking. The Goodhue County Safe Harbor Protocol team published the protocol of best practices for responding to survivors in August of 2019. The team is now training our colleagues and community members so that survivors of sexual exploitation and sex trafficking receive the services they need and exploiters and traffickers will be held accountable.

Community awareness is critical to end sexual exploitation and sex trafficking.

RECOMMENDATION: The HHS Department recommends that the HHS Board issue the attached proclamation in recognition of Sex Trafficking and Exploitation Awareness Month.

On December 20, 2016, the GCHHS Board approved a State mandated child protection 24/7 Assignment Plan for Goodhue County Health and Human Services, with a modification for the HHS Board to approve any annual wage adjustments. "The on-call rate will be adjusted based on the annual general adjustment approved by Goodhue County Board, if any.

On December 17, 2019, the Goodhue County Board approved a 2.75% general wage adjustment for non-union employees, which includes all GCHHS employees.

This is to request, a 2.75% general wage adjustment for the 24/7 child protection on call assignment compensation. This has been factored into the 2020 GCHHS approved budget.



Assessments/Investigations by Year


Child Protection Assessments/Investigations 2014-2019







- In 2017, Goodhue County was put on a Performance Improvement Plan (PIP) with DHS due to delays in establishing permanency
 - The State of Minnesota is not achieving federal standards and is at risk of a large financial penalty
 - Goodhue County would be fined for the percentage of cases that are out of compliance
 - In 2018 Goodhue County's data improved and the PIP ended

- Goodhue County was one of 33 counties to participate in Substance Abuse and Mental Health Services Administration's (SAMHSA) Systems of Care (SOC) grant to expand children's mental health services
 - Goodhue County is one of 16 counties to implement Collaborative Intensive Bridging Services (CIBS) through the SOC grant
 - GCHHS received \$193,896 to implement CIBS from October, 2018 to September, 2021
 - Other than staff and supervisor time, there has been <u>no cost</u> to Goodhue county to implement CIBS
 - Goodhue County's residential treatment costs have decreased, partially due to CIBS

On Call Child Protection Worker

- There were 175 total calls on the on-call phone in 2019.
 - Some of these were multiple calls about 1 incident
 - A worker had to respond to the scene in one situation to assist in placing a child
 - Some of the situations were about new CP cases, some current child protection cases, and some were new to our agency.
 - Approximately 10% of the calls came between the hours of 10pm to 6am.

Summary

- Child safety always has been and will continue to be our top priority.
- We are continuing to pursue and create additional services and supports for the families we serve
 - We especially want to utilize evidence based strategies that allow us to intervene earlier and prevent more serious issues

In CY 2019, the Goodhue County Health & Human Services Agency overall again had an outstanding financial year.

- We expended 100% (\$16,968,272) of our budget (\$16,942,054) 100% of the way through the year.
- We had collected 110% (\$18,605,873) of our anticipated revenue (\$16,942,054), 100% of the way through the year.

Resultantly, we were in the black with a net income of positive \$1,637,601.


Revenue from South Country Health Alliance (SCHA) who is an important county partner and provider were the following:

Children in Out of Home Placement:


The upward trend of increasing Out-of-Home Placement costs since 2013 turned downward again in 2019. We have expended 101.9% (\$1,828,347) of our budget (\$1,795,000), 100% of the way through the year, which still resulted in being over budget of \$33,347 or 1.86%.

In 2018 we were 22.73% over budget and in 2017 we were 72.97% over budget. There still is a state and national trend of increasing OHP costs, whereas in Goodhue County we are now seeing a decrease. We as an agency are working very hard to bring something different, innovative to our county to address this need. Two examples of such services are Collaborative Intensive Bridging Services (CIBS) which is part of the Substance Abuse and Mental Health Services Administration (SAMHSA) System of Care grant and Evidenced Based Family Home Visiting Program.



State Hospital Costs:

We did see an increase cost from 2018 with recipients living in state and private hospitals. For 2019, HHS had expenditures of \$321,780 and where we had a budget of \$325,000.




Consolidated Chemical Dependency Treatment Fund (CCDTF):

For 2019, HHS had expenditures of \$234,253 (117% of budget of \$200,000) this was \$34,253 over budget. These costs have slightly turned downward in 2019. Each county and tribe is responsible for the following: 1. Rule 25 assessment 2. Determination of financial eligibility 3. Placement of a person who needs Chemical Dependency (CD) treatment services. The county share of CCDTF costs is 22.95%. This also has been a state cost shift as the county share had been 15%. For SFY19 (7/1/18-6/30/19) Goodhue County CCDTF claims were \$1,326,909.

DHS is in the process of Substance Use Disorder (SUD) Reform.

Substance use disorder reform (SUD) seeks to transform the service continuum from an acute episodic model to a chronic and longitudinal model that includes ongoing recovery support services. The person-centered changes will seek to provide the right level of service at the right time and treat addictions like other chronic health conditions. DHS is currently seeking federal approval to add Comprehensive Assessment, peer support services, withdrawal management, and treatment coordination to the Medicaid benefit set. This will include approval of rates for the services.

7/1/20 Rule 25 (chemical use assessment) will no longer exist, but the CCDTF program will continue. The reform will provide Direct Access, which will allow clients to have a choice of Comprehensive Assessment (CA) Provider and Treatment (TX) Provider. We continue to learn more as DHS releases SUD Reform information to counties.



Other Program areas we have been monitoring in 2019

State Sex Offender Program:

We have expended 259% (\$134,603) of our budget (\$52,000) One recipient had been on a hold order for 11 months. This recipient was no longer on a holder order at the end of July. When recipients are on a hold order counties are required to pay 100% of the daily rate (\$373.00) instead of the 10% county share (\$33.70) per day if they are committed instead.

Sex Offender Therapy:

We have expended 555% (\$11,100) of our budget (\$2,000). We have seen several sex offenders this year. For the complete year of 2018, we had expenditures of \$1,554. Sex offender therapy is not a billable service to insurance and we are required to provide this service. A majority of the Sex Offender Therapy are court ordered. We did not occur any expenditures in the second half of the year.

Family Based Counseling:

We have expended 282% (\$56,348) of our budget (\$20,000). The majority of this increase has been with parenting evaluations where often we have to do one for each parent and the cost can be as high as \$4,000 per client. The majority based on the style of the evaluation is not a billable service to insurance. The large majority of these evaluations are court ordered.

Other Child Care:

We have expended 297% (\$74,189) of our budget (\$25,000). Paying the child care is a lower cost than if we had to pay for out of home placements for some of these children.

Salaries, Benefits, Overhead and Capital Equipment:

On agency salaries, benefits and overhead line items, we had expended 99.0% of our budget 100% of the way through the year. During 2019, HHS had seven promotions, five retirements, one voluntary demotion, one reduced FTE change, two new hires; one for Family Services Collaborative (FSC) and one for Statewide Health Improvement Partnership (SHIP) and no resignations.

Staffing Revenues Additional Staff:

All agency staff have again done an **outstanding** job of generating additional revenue so that additional staff could be hired without an increase in county levy funding.

For the fourth quarter report, total staffing revenue generated is 124%; \$5,005,687 100% through the year of the total 2019 budget of \$4,037,399 for these revenue categories. This generated an additional \$968,288 over budget.

As with any position(s) that are retiring/resigning we review our agencies needs and look to see if our needs are the same or if they have changed over time with any position(s) when looking whether to replace/change/re-classify or not replace that position(s).

In 2020 we are expecting to have some retirements, along with adding some additional staff where the need is there due to increasing client demand for services and additional required paperwork. We will reconfigure work duties and assigning staff to areas that have more program and service need in order to achieve greater efficiencies and outcomes. We will be presenting these changes and requests at a near future board meeting with the funding from the additional revenue that is currently being generated and staff savings to make these requests to be levy neutral to the county.

Fund Balance

Going forward, our Cash Operating Fund Balance Assigned for Health & Human Services Expenditures (\$7,672,008) is at 42.93% of our 2020 budget (\$17,871,630) (per Goodhue County Comprehensive Fund Balance Policy is to maintain a goal of 30-40% in all other funds) on December 31, 2019. HHS currently has Committed and Assigned Fund Balance of \$750,000. Total cash balance as of 12-31-19 is \$8,422,008

Future:

Some of the uncertainties that will have an impact on HHS department are the continued outcomes of the recommendations from the Governor's Taskforce for the Protection of Children, which now had implemented the new response timelines.

We will work closely with DHS, Association of Minnesota Counties, Minnesota Association of County Social Service Administrators, Governor's Office and State Legislature on dealing with the issues that have surfaced with DHS.

We do not know what will take place with the Affordable Care Act (ACA) at the federal level and/or MNsure in Minnesota.

We did have great news on the outcome with our county-based purchasing health plan South Country Health Alliance (SCHA). There is hope that DHS or state legislation will change the procurement process for county-based purchasing health plans.

We know there will be continued changes with children residential treatment centers' reclassification as institute for mental diseases (IMDs), chemical dependency services and mobile crisis funding which may have increased financial implications to the counties.

We will continue to have uncertainties regarding out of home placements, state hospital costs, consolidated chemical dependency treatment fund, and Substance Use Disorder Reform (SUD).

During 2020, HHS will continue to work on workforce development, controlling public assistance costs, quality improvements, and working with our local, regional and state community members and partners to focus on improving health and reducing costs.

We believe we are positioned as well as one can expect in terms of dealing with uncertainties and increasing service and workload demands.

Our department's professional staff, desire to serve the public and team spirit coupled with the dollars that we have in reserve, should help us greatly in managing the work and services the next biennium.


Quality Improvement

IV-E reimbursement is federal funding to reimburse counties for foster care costs of children who meet certain criteria. Increasing communication and other changes to the process in 2018 increased IV-E reimbursement collected by GCHHS 39%.



Wi-Fi cards are available for staff to increase efficiency at customer visits outside the HHS building. Creating a check-out system and educating staff reduced complaints of missing Wi-Fi cards from 8 in May 2018 to only 1 in all of

October and November.


We collected and analyzed input from 5 customer groups.

Follow Along is a screening program that identifies children in need of early intervention. By texting and emailing reminders to parents, with funding from Every Hand Joined, the questionnaire return rate increased from 33% in April 2018 to 53% in November 2018.

The new Goodhue County Community Health Improvement Plan (CHIP) was completed in December 2018. It is available at co.goodhue.mn.us/CHIP




Top 3 needs based on the CHIP.



New Grants in 2018

Two innovative programs we have brought into Health & Human Services are Collaborative Intensive Bridging Services (CBIS) and Evidenced Based Family Home Visiting Program.

In collaboration with other counties and agencies, Goodhue County is implementing CIBS, which is an integrated mental health intervention that combines rigorous targeted case management and intensive community-based therapeutic services with a brief residential treatment placement for children. CIBS is an evidence-based intervention that has been successful in improving the overall functioning of children with serious emotional disturbance and reducing the need for more intensive mental health services including less need for out of home placements.

Evidence Based Home Visiting program is an intensive model rooted in the belief that early, nurturing relationships are the foundation for life-long, healthy development with the evidenced based goals to be able to reduce the rates/numbers of children who suffer abuse and neglect and resulting in healthier, thriving children and families with less need for out of home placements.
