Staff Present: Commissioner Todd Greseth, Commissioner Brad Anderson, County Administrator Scott Arneson, Lucas Dahling, and Andrea Benck.

**2025 Outside Agency Funding Request.** Outside Agencies reviewed their 2025 funding requests with the committee. The county currently has a contract in place with SELCO which calls for an increase each year based on the increase in Consumer Price Index (CPI). For 2025 the allocation for SELCO is \$591,747, which is based on the 2023 CPI percentage increase.

Two new requests were made this year:

1. Hope and Harbor Connecting Hope- \$20,000
2. Friends of the Fredrich Center- \$20,000
