LAND USE MANAGEMENT DIRECTOR'S REPORT

Request for Final Plat Review for the McKeag Addition in Stanton Township. The request was submitted by Daniel McKeag, representing the estate of Audrey McKeag, for final plat review. The proposed plat will be named the "McKeag Addition". The purpose of the plat is not to develop the land or construct homes, instead the applicant is requesting the plat to divide land into separate ownership. The Planning Commission recommended approval.

The County Board was being asked to approve these delegation agreements.

is complaint with the County’s zoning ordinance and County’s comprehensive plan, with the following conditions:

1. The site must obtain site plan review approval from MnDOT.
2. Any retail operations associated with the business must obtain a retail registration from Goodhue County once Leon Township has delegated retail registrations.
3. Building permits must be applied for and issued before any work to the building can commence.
4. The site must comply with the County’s septic regulations and obtain applicable septic permits from Goodhue County Environmental Health.
5. The applicant must obtain and maintain compliance with the Minnesota Office of Cannabis Management’s license for a cannabis business.
6. The Interim Use Permit expires upon any one of the following triggering events:
 - a. Closure of the business
 - b. Sale of the business or land to anyone not associated with: ACE Cannabis LLC. 1400 Medora Road, Mendota Height, MN 55118, or 7860 365th LLC. 1400 Medora Road, Mendota Heights, MN 55118
 - c. Violation of the terms of the County’s CUP/IUP requirements as found in the Goodhue County Zoning Ordinance or any of the terms and conditions of this permit.
