### Special Event Permit Application

Notice to Applicant: You are required by Minnesota State Statute 86B.121 to have a sheriff's permit prior to holding an event on any body of water. There is no charge for this permit in Goodhue County.

In order to have a permit issued the permit must be filed with our office at least 15 days prior to the event.

- A. All state laws and county ordinances will be observed.
- B. Boating accidents resulting in \$2000.00 property damage, injury or death will promptly be reported to the Goodhue County Sheriff's Office. Emergency # 911 and non-emergency Dispatch 651-385-3155.
- C. In planning your event, please consider the following:
  - 1) Impact on waterway, surrounding shoreline and residence.
  - 2) Access for police, fire and medical services for your event.
  - 3) Does your event require a Minnesota DNR Permit or if on Federal Waterways a Coast Guard Permit.
- D. A sheriff's deputy may be assigned to patrol the event.
