Special Event Permit Application

Notice to Applicant: You are required by Minnesota State Statute

86B.121 to have a sheriff's permit prior to holding an event on any body of water. There is no charge for this permit in Goodhue County.

In order to have a permit issued the permit must be filed with our office at least 15 days prior to the event.

A. All state laws and county ordinances will be observed.

B. Boating accidents resulting in \$2000.00 property damage, injury or death will promptly be reported to the Goodhue County Sheriff's Office. Emergency # 911 and non-emergency Dispatch 651-385-3155.

C. In planning your event, please consider the following:

1) Impact on waterway, surrounding shoreline and residence.

2) Access for police, fire and medical services for your event.

3) Does your event require a Minnesota DNR Permit or if on Federal Waterways a Coast Guard Permit.

D. A sheriff's deputy may be assigned to patrol the event.
